## HOUSE BILL 192

## 54TH LEGISLATURE - STATE OF NEW MEXICO - FIRST SESSION, 2019

AN ACT

RELATING TO MOTOR VEHICLES; PROVIDING THAT A MOTORIST MUST

PROVIDE AT LEAST A FIVE-FOOT DISTANCE WHEN PASSING A BICYCLIST;

ESTABLISHING A PENALTY ASSESSMENT MISDEMEANOR.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

**SECTION 1.** A new Section 66-7-376 NMSA 1978 is enacted to read:

"66-7-376. [NEW MATERIAL] APPROACHING OR PASSING BICYCLIST.--

A. A driver of a motor vehicle shall proceed with caution when approaching or passing a person on a bicycle and shall pass the bicyclist at a reasonable speed and keep a safe distance from the bicyclist; provided that in no event shall a distance of less than five feet be considered a safe distance within the meaning of this section, and provided further that

the motorist shall not pass the bicyclist if the requirements
of this section cause the motorist to cross the center line of
the road when there is a vehicle approaching in the opposite
direction, but a motorist may cross the center line,
notwithstanding the provisions of Section 66-7-315 NMSA 1978,
if allowing the requisite five feet requires the motorist to
cross the center line and there is no oncoming traffic.
R A violation of this costion is a nonalty

B. A violation of this section is a penalty assessment misdemeanor."

SECTION 2. Section 66-8-116 NMSA 1978 (being Laws 1978, Chapter 35, Section 524, as amended) is amended to read:

"66-8-116. PENALTY ASSESSMENT MISDEMEANORS--DEFINITION-SCHEDULE OF ASSESSMENTS.--

A. As used in the Motor Vehicle Code and the Boat Act, "penalty assessment misdemeanor" means violation of any of the following listed sections of the NMSA 1978 for which, except as provided in Subsections D through F of this section, the listed penalty assessment is established:

- B. The term "penalty assessment misdemeanor" does not include a violation that has caused or contributed to the cause of an accident resulting in injury or death to a person.
- C. When an alleged violator of a penalty assessment misdemeanor elects to accept a notice to appear in lieu of a notice of penalty assessment, a fine imposed upon later

conviction shall not exceed the penalty assessment established for the particular penalty assessment misdemeanor and probation imposed upon a suspended or deferred sentence shall not exceed ninety days.

- The penalty assessment for speeding in violation of Paragraph (5) of Subsection A of Section 66-7-301 NMSA 1978 is twice the penalty assessment established in Subsection A of this section for the equivalent miles per hour over the speed limit.
- Upon a second conviction for operation without a permit for excessive size or weight pursuant to Section 66-7-413 NMSA 1978, the penalty assessment shall be two hundred fifty dollars (\$250). Upon a third or subsequent conviction, the penalty assessment shall be five hundred dollars (\$500).
- Upon a second conviction for transport of a reducible load with a permit for excessive size or weight pursuant to Subsection N of Section 66-7-413 NMSA 1978 more than six miles from a port-of-entry facility on the border with Mexico, the penalty assessment shall be five hundred dollars Upon a third or subsequent conviction, the penalty assessment shall be one thousand dollars (\$1,000)."

SECTION 3. EFFECTIVE DATE. -- The effective date of the provisions of this act is July 1, 2019.
